### Disclaimer

The data set from 1 January 2015 to 1 January 2016 was revised in September 2017 to address minor inaccuracies relating to exemptions being incorrectly recorded. The discrepancy between the data sets is generally 3 per cent or below.

It is important to be aware that historical changes to licence categories may also impact on this data.

### Explanatory Notes

#### Department of Justice regions:

#### Licence Types

BYO Permits	allow for the consumption of alcohol on-premises, but no sales
Licences	authorise the sale (and consumption) of alcohol in accordance with the licence conditions
