## 2. EXECUTIVE SUMMARY

The approval of the EPBC Act referral 2017/8018 was issued to Regional Roads Victoria (formerly VicRoads) on the 25th of November 2019 for construction of a Safer Roads Infrastructure Project on the Geelong Bacchus Marsh Road between Lara and Maddingly, Victoria.

Regional Roads Victoria (RRV), formerly VicRoads, is now a part of the Department of Transport and Planning (DTP). This report recognizes RRV as the approval holder and authority for the project.

In accordance with Condition 10 of the *Environment Protection and Biodiversity Conservation Act 1999* approval (EPBC 2017/8018), within 60 days of every 12month anniversary of the commencement of construction (7<sup>th</sup> November 2019), the Roads Corporation must publish a report on the VicRoads website addressing compliance with each of the conditions of this approval, including implementation of the conditions under the EPBC Act set out in Annexure A of the Approval Decision notices. Documentary evidence providing proof of the date of publication and non-compliance with any of the conditions of this approval will be provided to the Department at the same time as the compliance report is published.

This compliance report addresses the current status of the Geelong-Bacchus Marsh Road-between Lara and Maddingly Safer Roads Infrastructure Project against the conditions for approval of the EPBC Referral Act 2017/8018 for the environmental activities carried out between 31<sup>st</sup> December 2022 and 31<sup>1st</sup> December 2023. This is the fourth report to be prepared under the EPBC Act approval 2017/8081 for this Project.

## **3. INTRODUCTION**

The Geelong-Bacchus Marsh Road Upgrade Project is located between Geelong and Bacchus Marsh, approximately 60 km north-west of Melbourne, Victoria. The project consists of three separate sections of road extending approximately 42 km between Heales Road, Lara and Woolpack Road, Maddingley. Broadly, the road upgrade works include the construction of overtaking lanes, installation of wire rope barriers, intersections improvements and widening of traffic lanes and road shoulders. The extent of the project area is summarized on Figure 1 (page 20), and includes:

- Project section 2: Little River-Ripley Road to Ballan Road (approximately 13km); and
- Project section 3: Ballan Road to Woolpack Road (approximately 9km).

VicRoads (RRV) was awarded Traffic Accident Commission (TAC) Project funding under the Safe System Road Infrastructure Program by the Victorian State Government in 2016-17 to complete road safety improvement works on the Geelong Bacchus Marsh Road between Lara and Maddingley. Funding was granted based on the crash history and the need to address deficiencies and unprotected hazards throughout this section of highway.

Improvements and implementation of road safety treatments to this stretch of highway will benefit all road users and assist in reducing serious trauma.

A Google Earth aerial image of the Project area can be found in Appendix A of this report.

## 4. BACKGROUND

Geelong-Bacchus Marsh Road has been identified as one of Victoria's high-risk rural roads, with six fatalities and 32 serious injuries occurring between 2010 and 2017.

Geelong-Bacchus Marsh Road is an important freight route between Geelong and Bacchus Marsh, serving as a key road for agricultural industries. The road is also important for commuters, connecting the towns of Lara, Bacchus Marsh and the city of Geelong.

The purpose of this road safety project is to reduce the severity and occurrence of run-off road accidents through targeted road safety improvements to the Geelong Bacchus Marsh Road between Lara and

Maddingley. The implemented road safety works include:

- Wide centerline markings to ensure a safe distance between vehicles travelling in opposite directions to help prevent head on collisions,
- Four roundabouts along Geelong-Bacchus Marsh Road at the intersections of Elcho Road, Ballan Road, Glenmore / Nerowie Road and Parwan Exford Road to help slow traffic and create safer intersections to reduce the likelihood and severity of crashes;
- Overtaking lanes in both directions at various locations;
- Flexible safety barriers to prevent run off road crashes;
- Intersection improvements including left and right-hand turning lanes at various intersections;
- Safer speed limits of 80km/h in various locations;
- Rumble strips on the left-hand side and centerline to warn drivers when they are veering out of their lane;

All safety works were undertaken in accordance with current Austroads and VicRoads Guidelines. The safety upgrades will provide benefits to the community and road users.

Road safety infrastructure such as flexible safety barriers, roundabouts, wide centerline treatments and rumble strips help prevent the most common crash types, head-on and run-off-road collisions, which in 2015 were responsible for 40% of Victoria's road deaths and serious injuries.

Project works were carried out from the 6<sup>th</sup> of January 2020 until the 3<sup>rd</sup> of October 2022.

#### 4.1 PURPOSE OF THIS DOCUMENT

The purpose of this document is to assess the compliance of the Geelong Bacchus Marsh Road between Little Ripley Rd and Woolpack Rd, for the Safe Systems Roads Infrastructure Project (SSRIP) with the EPBC Conditions of approval EPBC 2017/8018. The EPBC conditions of approval includes the requirement to:

- Must not impact more than the below mentioned area for the EPBC Act 1999 listed species:
  - a) 5.47 ha of habitat for the Striped Legless Lizard
  - b) 5.47 ha of habitat for the Golden Sun Moth
  - c) 2.5 ha of Natural Temperate Grassland of the Victorian Volcanic Plain
- Prior to commencement of the action, to compensate for the impact to Striped Legless Lizard, Golder. Sun Moth, and Natural Temperate Grassland of the Victorian Volcanic Plain, the approval holder must:
  - a) Execute a bond agreement with Trust for Nature to hold funds in trust for the purpose of managing the offset site. A copy of the signed bond agreement must be provided to the Department within fourteen days following execution.
  - Provide a sum of at least \$800,000 (excluding GST) to be held by Trust for Nature for the purpose of managing the offset site. Proof of the provision of funds into trust must be provided to the Department within 14 days of payment;
- Within 3 months of the execution of the bond agreement with *Trust for Nature*, the approval holder must execute a credit trading agreement with *Trust for Nature* and the owner of the offset site. A copy of the signed credit trading agreement must be provided to the Department within 14

days of execution.

- Within 9 months of the execution of the credit trading agreement the approval holder must provide written evidence to the Department that the signed Deed of Covenant has been registered on the title of the offset site.
- Once the Deed of Covenant has been registered on the title of the offset site the approval holder must implement the offset management plan for the life of the approval.

The approval then refers to standard administrative conditions outlined in part B.

#### 4.2 ENVIRONMENTAL PROTECTION AND BIODIVERSITY ACT 1999 REQUIREMENTS

The objective of the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act) is to manage and protect flora and fauna of national and international significance including ecological communities and heritage places of national environmental significance.

#### 4.2.1 EPBC Approval

Approval of the Commonwealth Minister for the Environment is required under the EPBC Act if an 'action' will have or is likely to have a significant impact on a matter of national environmental significance. Due to potential impacts on a threatened species, Striped Legless Lizard, Golden Sun Moth and Natural Temperate Grassland of the Victorian Volcanic, the project was referred to the then Department of Environment and Energy (DoEE) now known as the Department of Agriculture, Water and the Environment (DAWE).

A decision was issued by the Department on the 24<sup>th</sup> August 2017 determining that the proposal was a "controlled action" by the Federal Minister for the Environment and Energy. On 16 January 2018, it was further decided by DoEE that the proposed action would be assessed by preliminary documentation as the project is likely to have a significant impact on listed threatened species and communities (section 18 and 18A) protected under Part 3 of the EPBC Act.

The proposed action under the EPBC Act originally identified an impact to matters of NES totalling 7.9 ha, including:

- 7.9 ha Striped Legless Lizard and Golden Sun Moth habitat (known and potential); and
- 3.7 ha of NTGVVP.

Through a detailed design process, the project has been able to revise the extent of proposed works and therefore reduce the impact to matters of NES, which now totals 5.47 ha of Striped Legless Lizard and Golden Sun Moth habitat and 2.5 ha of NTGVVP.

Final approval was issued to VicRoads on the 07<sup>th</sup> July 2019.

#### 4.2.2 Performance and Compliance Reporting

Under Condition 10 of the approved EPBC Act referral 2017/8018, an annual compliance assessment report is required to be published on VicRoads website within 60 business days of every 12 month anniversary of the date of commencement of construction (4<sup>th</sup> of February, 2021, 2022, 2023 & 2024), addressing compliance with each of the conditions of the approval (See Appendix C for Commencement of the Action letter).

#### 4.2.3 Non-Compliance Reporting

Within the offset management plan DTP are responsible for meeting specific offset requirements, this includes regular audits of the offset management plan's (OMP) implementation and effectiveness. A year one audit report of the offset management plan was not completed in 2021. DTP informed DCCEEW on the 8<sup>th</sup> of May 2023 and were advised to conduct audits of the OMP in year 3, 5, 8 and 10 instead of year 1, 4, 8 & 10. We have acknowledged and address the oversight and provided an offset audit for year 3.

## **5. PROJECT COMPLIANCE**

#### 5.1 COMPLIANCE WITH EPBC CONDITIONS OF APPROVAL

As required in the EPBC Act approval dated 07<sup>th</sup> July 2019 from the DoEE, this report has been prepared to provide the Department with a status update on each of the conditions of approval.

The Department of Transport and Planning has complied with the conditions referenced in the EPBC Act approval 2017/8018 for the annual reporting period. A summary of the performance and compliance with each of the 16 conditions of approval has been provided in Section 6 of this report.

## 6. PERFORMANCE AND COMPLIANCE OF EPBC 2017/8018

The table below provides details of the status of compliance with the conditions of the EPBC Act approval notice (EPBC 2017/8018) for the Geelong Bacchus Marsh Road between Lara and Maddingley.

Aerial photographs taken can verify works did not extend outside the project work area. *No new reports have been generated, as all the native vegetation removal occurred throughout 2019 to 2021. Appendix B has a list of all the reports generated throughout life of the project.
